# Background

- Poor knowledge about Natura 2000 forest sector (only 7% of Italian citizens know RN2000)
- Open conflict between productive management and protectionists
- Low incidence of investments of the Rural Development Program aimed at the Habitat Directive
- Different methods of application of forest interventions and for the conservation of species


# Objectives




